(Tech) and Special Situations Technology Fund II, L.P. (Tech2). 3,158,900 shares of Common Stock are held by SSFQP, 950,000 shares of Common Stock are held by Cayman, 581,385 shares of Common Stock are held by PE, 530,942 shares of Common Stock are held by Tech and 3,290,393 shares of Common Stock are held by Tech2. The interest of Marxe and Greenhouse in the shares of Common Stock owned by SSFQP, Cayman, PE, Tech and Tech2 is limited to the extent of his pecuniary interest.
