- The original RSU grant was for 25,000 shares with the following vesting schedule: 7,000 shares of the RSUs vested on December 28, 2007, 6,000 shares vested on July 10, 2008 and the remaining RSUs shall vest each six (6) months thereafter such that the RSUs shall be fully vested on July 10, 2010.
- (3) The original RSU grant was for 17,862 shares with the following vesting schedule: 33.3% of the RSUs vested on July 10, 2008 and an additional 16.7% shall vest each six (6) months thereafter such that the RSUs shall be fully vested on July 10, 2010.
