**Item 8.01. Other Events**

On April 28, 2014, GlaxoSmithKline plc (GSK) and Theravance, Inc. issued a press release announcing that ANORO(TM) ELLIPTA(R) (umeclidinium and vilanterol inhalation powder), the first once-daily product approved in the United States (U.S.) that combines two long-acting bronchodilators in a single inhaler for the maintenance treatment of chronic obstructive pulmonary disease (COPD), is now available to retail pharmacies in the U.S. ANORO(TM) ELLIPTA(R) is a combination anticholinergic/long-acting beta2-adrenergic agonist (anticholinergic/LABA) indicated for the long-term, once-daily, maintenance treatment of airflow obstruction in patients with COPD, including chronic bronchitis and/or emphysema. ANORO(TM) ELLIPTA(R) is not indicated for the relief of acute bronchospasm or for the treatment of asthma. The FDA-approved strength is umeclidinium/vilanterol 62.5/25mcg. ANORO(TM) ELLIPTA(R) has been developed under the 2002 LABA collaboration between Glaxo Group Limited and Theravance, Inc.
