**MOSCOW, RUSSIAN FEDERATION JULY 11, 2006 MOBILE TELESYSTEMS OJSC ( MTS - NYSE: MBT), THE LARGEST MOBILE PHONE OPERATOR IN RUSSIA AND THE CIS, ANNOUNCES THAT ITS CONSOLIDATED SUBSCRIBER BASE REACHED 64.10 MILLION USERS ON JUNE 30, 2006.**

During June 2006, MTS consolidated subscriber base increased by 1.21 million subscribers, of which 0.88 million were added in Russia.
