MOSCOW, RUSSIAN FEDERATION AUGUST 11, 2006 MOBILE TELESYSTEMS OJSC ( MTS - NYSE: MBT), THE LARGEST MOBILE PHONE OPERATOR IN RUSSIA AND THE CIS, ANNOUNCES THAT ITS CONSOLIDATED SUBSCRIBER BASE REACHED 65.72 MILLION USERS ON JULY 31, 2006.

During July 2006, MTS consolidated subscriber base increased by 1.62 million subscribers, of which 1.15 million were added in Russia.
