### Item 5.07 Submission of Matters to a Vote of Security Holders

On February 24, 2011, Inland Western Retail Real Estate Trust, Inc. (the Company) held a special meeting of stockholders (the Special Meeting). At the Special Meeting, the stockholders voted on (1) a proposal to approve an amendment and restatement of the Company is charter (the Charter Amendment) and (2) a proposal to permit the Board of Directors of the Company to adjourn the Special Meeting, if necessary, to solicit additional proxies in favor of the Charter Amendment proposal if there are not sufficient votes for the proposal. The foregoing proposals were described in detail in the Company is definitive proxy materials previously filed with the Securities and Exchange Commission on December 8, 2010.

All of the proposals were approved by the Company s stockholders at the Special Meeting. The voting results were as follows:
