**Item 8.01. Other Events.**

On April 1, 2014, Duke Energy Corporation (the Company) entered into an underwriting agreement, dated as of April 1, 2014 (the Underwriting Agreement), with Barclays Capital Inc., RBC Capital Markets, LLC, Scotia Capital (USA) Inc., and UBS Securities LLC, as representatives of the several underwriters named therein (the Underwriters), pursuant to which the Company agreed to issue and sell to the Underwriters \$400,000,000 aggregate principal amount of the Company's Floating Rate Senior Notes due 2017 (the 2017 Notes) and \$600,000,000 aggregate principal amount of the Company's 3.75% Senior Notes due 2024 (together with the 2017 Notes, the Securities). The Securities will be issued pursuant to an Indenture, dated as of June 3, 2008 (the Indenture), by and between the Company and The Bank of New York Mellon Trust Company, N.A., as trustee (the Trustee), as amended and supplemented by various supplemental indentures thereto, including the Eleventh Supplemental Indenture, dated as of April 4, 2014 (the Eleventh Supplemental Indenture), between the Company and the Trustee, relating to the Securities. The disclosure in this Item 8.01 is qualified in its entirety by the provisions of the Indenture, the Eleventh Supplemental Indenture, which is filed as Exhibit 4.1 hereto, and the Underwriting Agreement, which is filed as Exhibit 99.1 hereto. Such exhibits are incorporated herein by reference. Also, in connection with the issuance and sale of the Securities, the Company is filing a legal opinion regarding the validity of the Securities as Exhibit 5.1 to this Form 8-K for the purpose of incorporating the opinion into the Company's Registration Statement No. 333-191462.
