Item 7.01. Regulation FD Disclosure.

In connection with the previously announced cash dividend of \$0.25 per share of Theravance, Inc. (the Company) paid on September 18, 2014 to stockholders of record as of the close of business on August 28, 2014, the conversion rate (the Conversion Rate) with respect to the Company's unsecured convertible promissory notes due 2023 (the 2023 Notes) was adjusted. The Conversion Rate was adjusted from 46.9087 shares of the Company's common stock per \$1,000 principal amount of the 2023 Notes to 47.4323 shares of the Company's common stock per \$1,000 principal amount of the 2023 Notes, which represents an adjusted conversion price of approximately \$21.08 per share.
