Dear Pension Plan Participant:

On December 11, 2015, DuPont announced that it had reached an agreement to enter into a merger of equals with The Dow Chemical Company, with an expected closing in the second half of 2016. Following the completion of the merger, the companies intend to subsequently pursue a separation of the combined company into three independent, publicly traded companies, focused on Agriculture, Material Science and Specialty Products, through one or more tax efficient transactions. Recognizing that our retirees understandably have questions about this planned merger, I want to provide some context regarding the DuPont Pension and Retirement Plan.

The Pension and Retirement Plan (the Plan) remains able to meet its obligations to existing pensioners and other Plan participants through assets held in a secure trust at State Street Bank. The bank is and will remain a separate legal entity from DuPont, and will not be affected by the merger. DuPont's funding policy for the Plan ensures that contributions to the Plan meet funding requirements under U.S. laws and regulations. Also, regarding health care benefits, there are no anticipated changes to the 2016 health care plans or pricing. The company will continue to regularly evaluate our health care programs to provide competitive benefits, and, as always, provide advance notification of any changes.

As we work our way through plans to complete the merger, we will work to ensure that our obligations to the Plan and its participants are in full compliance with all legal and regulatory requirements. We will continue to update you as we progress with the merger and the intended creation of three globally competitive businesses.

Thank you for your years of dedicated service to DuPont.

In connection with the proposed transaction, The Dow Chemical Company ( Dow ) and E. I. du Pont de Nemours and Company ( DuPont ) will cause Diamond-Orion HoldCo, Inc.
