This amendment No. 2 to statement on schedule 13D (this <u>Statement</u>) amends and supplements the statement on Schedule 13D filed by each of Mr. Charles Chao and New Wave MMXV Limited (New Wave, and together with Mr. Charles Chao, the Reporting Persons) with the U.S. Securities and Exchange Commission (the Commission ) on November 16, 2015, as amended by amendment No. 1 filed on June 16, 2017 (the Original Filing ), with respect to the ordinary shares, par value \$0.133 per share (the Ordinary Shares ), of Sina Corporation, a company organized under the laws of the Cayman Islands (the Company), whose principal executive offices are located at SINA Plaza, No. 8 Courtyard 10 West, Xibeiwang E. Road, Haidian District, Beijing 100193, People s Republic of China. Except as amended hereby, the Original Filing remains in full force and effect. Capitalized terms used but not defined in this Statement have the meanings ascribed to them in the Original Filing. **Item 4. Purpose of Transaction** Item 4 of the Original Filing is hereby amended and supplemented by the following: The description of the Share Subscription Agreement under Item 6 is incorporated herein by reference in its entirety. Item 5. Interest in Securities of the Issuer. Item 5(a), (b) and (c) of the Original Filing is hereby amended and restated as follows: The responses of Mr. Charles Chao and New Wave to Rows (7) through (13) of the cover pages of this Statement are hereby incorporated by reference in this Item 5. As of the date of this filing, Mr. Charles Chao beneficially owned 8,841,456 Ordinary Shares, representing approximately 12.4% of the Company s total issued and outstanding Ordinary Shares. The 8,841,456 Ordinary Shares beneficially owned by Mr. Charles Chao comprise (i) 7,944,386 Ordinary Shares held by New Wave, (ii) 767,070 Ordinary Shares held by Mr. Charles Chao, (iii) 40,000 Ordinary Shares issuable upon exercise of options exercisable within 60 days after the date of this filing, and (iv) 90,000 Ordinary Shares issuable upon vesting of restricted share units within 60 days after the date of this filing.

The percentage of Ordinary Shares beneficially owned by each Reporting Person is based on 71,514,660 Ordinary Shares outstanding as of September 15, 2017 (excluding 9,606,576 Ordinary Shares that have been repurchased but not cancelled) disclosed in the Company's proxy

statement furnished to the Commission on Form 6-K on September 25, 2017.
