Item 1.01 - Entry into a Material Definitive Agreement.

Merger Agreement

On January 10, 2018, Heritage Commerce Corp, a California corporation (*HCC*), and its banking subsidiary Heritage Bank of Commerce, a California state-chartered commercial bank (*HBC*), entered into an Agreement and Plan of Merger and Reorganization (the *Merger Agreement*) with United American Bank, a California state-chartered commercial bank (*UAB*), pursuant to which HCC will acquire UAB by merging UAB with and into HBC (the *Merger*). HBC will survive the Merger and will continue the commercial banking operations of the combined bank following the Merger. ATBancorp, an Iowa corporation (*ATB*) that owns approximately 83% of UAB 's common stock and all of UAB 's preferred stock, is also a party to the Merger Agreement. The transaction is intended to qualify as a tax-free reorganization under the applicable provisions of the Internal Revenue Code.

Subject to the terms of the Merger Agreement, upon completion of the Merger, (i) each outstanding UAB common share, no par value per share (*UAB Common Share*), excluding dissenting shares, will be converted into the right to receive 2.1644 (*Per Share Exchange Ratio*) shares of HCC common stock, no par value per share (*HCC Common Stock*); (ii) each outstanding share of Series D Non-Cumulative Voting Preferred Stock, no par value, (*Series D Preferred Stock*) will be converted into the right to receive the Per Share Exchange Ratio multiplied by the equivalent number of UAB Common Shares the holder would receive upon conversion of the Series D Preferred Stock; (iii) each outstanding share of Series E Non-Cumulative Voting Preferred Stock, no par value, (*Series E Preferred Stock*) will be converted into the right to receive the Per Share Exchange Ratio multiplied by the equivalent number of UAB Common Shares the holder would receive upon conversion of the Series E Preferred Stock; (iv) each outstanding share of Fixed Rate Non-Cumulative Perpetual Preferred Stock, Series A, no par value, (*Series A Preferred Stock*) will be converted into the right to receive \$1,000 in cash; and (v) each outstanding share of Fixed Rate Non-Cumulative Perpetual Preferred Stock, Series B, no par value, (*Series B Preferred Stock*) will be converted into the right to receive \$1,000 in cash. UAB has no stock options issued and outstanding. Based on HCC 's closing price of \$15.65 per share of HCC Common Stock on January 9, 2018, the penultimate trading date before the transaction was announced, the aggregate Merger consideration to be received by holders of UAB Common Share and UAB Common Share equivalents was valued at approximately \$44.2 million or \$33.87 for each of the UAB Common Shares and UAB Common Shares equivalents and the total transaction value (including the cash out of the Series A Preferred Stock and the Series B Preferred Stock) is approximately \$53.3 million. The Per Share Exchange Ratio is fixed and the aggregate and per share values of the Merger consideration will fluctuate between the date of the Agreement and the date that the Merger is completed. On a pro forma basis, and assuming that HCC issues approximately 1.9 million shares of HCC Common Stock pursuant to its Agreement and Plan of Merger and Reorganization with Tri-Valley Bank dated as of December 20, 2017, the current shareholders of holders of UAB will own approximately 6.6% of the issued and outstanding HCC Common Stock following the Merger.

The parties have made representations, warranties and covenants customarily found in merger agreements involving depository institutions.

Completion of the Merger is subject to certain customary conditions, including (i) approval by the UAB shareholders, (ii) the absence of any governmental order or law prohibiting the consummation of the Merger, and (iii) effectiveness of the Securities and Exchange Commission (*SEC*) registration statement for the HCC Common Stock to be issued as consideration in the Merger. The obligations of HCC and UAB and to consummate the Merger are also conditioned upon (a) subject to certain exceptions, the material accuracy of the representations and warranties made to it, (b) performance in all material respects by the other parties of their obligations under the Merger Agreement, (c) receipt by each party of a tax opinion to the effect that the Merger will qualify as a reorganization within the meaning of Section 368(a) of the Internal Revenue Code of 1986, as amended, and (d) the absence of a material adverse effect with respect to the other party since the date of the Merger Agreement. The obligation of HCC to consummate the Merger is also conditioned upon (w) the adjusted shareholders ' equity of UAB, and UAB 's and nonperforming assets satisfying specific levels, (x) the receipt of required regulatory approvals and such approvals not containing materially burdensome regulatory conditions, and (y) the holders of not more than ten percent of the outstanding UAB Common Shares having duly exercised their dissenters ' rights under California law.

Both HCC and UAB may mutually agree to terminate the Merger Agreement without further liability to the other. Either party may agree to terminate the Merger Agreement if the Merger is not consummated by October 1, 2018, the shareholders of UAB do not approve the Merger Agreement, or any governmental entity whose approval is required to consummate the Merger does not approve the Merger. Further, UAB may terminate the Merger Agreement for a superior proposal under certain conditions, and, HCC can terminate the Merger Agreement if the UAB board of directors withdraws or changes its recommendation to its shareholders prior to the UAB shareholder meeting held to approve the Merger Agreement. In addition, either party may terminate the Merger Agreement if the other party is in material breach of any of its representations, warranties or agreements set forth in the Merger Agreement that are not cured such that the applicable closing conditions are not satisfied.

UAB has agreed that it will pay HCC a termination fee of \$2.0 million if (i) HCC terminates the Merger Agreement because UAB breaches any of its obligations relating to alternative acquisition proposals, including withdrawing its recommendation of the Merger Agreement to its shareholders; (ii) UAB terminates the Agreement in favor of a superior proposal (after providing HCC the right to increase the Merger consideration), or (iii) either HCC or UAB terminate the Merger Agreement because the UAB shareholders do not approve the Merger Agreement after an alternative acquisition proposal has been announced and, within 12 months thereafter, UAB enters into an agreement relating to an alternative acquisition proposal.

A committee comprised of independent members of UAB's Board of Directors directed the negotiations for UAB and upon the unanimous recommendation of the independent committee's members, UAB's Board of Directors unanimously approved the Merger Agreement. HCC's Board of Directors has also approved the Merger Agreement.

Although no assurance can be provided, the parties anticipate that the Merger will close in the second quarter of 2018.

The Merger Agreement and the above description of the Merger Agreement have been included to provide investors and security holders with information regarding the terms of the Merger Agreement. The Merger Agreement and the above description are not intended to provide any other factual information about HCC, HBC, UAB and ATB, or their respective subsidiaries or affiliates. The representations, warranties and covenants contained in the Merger Agreement were made only for purposes of the Merger Agreement and as of specific dates, were solely for the benefit of the parties to the Merger Agreement, may be subject to limitations agreed upon by the parties, including being qualified by confidential disclosures made by each contracting party to the other for the purposes of allocating contractual risk between them rather than establishing these matters as facts and may be subject to standards of materiality applicable to the contracting parties that differ from those applicable to investors. Investors should not rely on the representations, warranties and covenants or any description thereof as characterizations of the actual state of facts or condition of HCC, HBC, UAB or ATB or any of their respective subsidiaries, affiliates or businesses. Moreover, information concerning the subject matter of the representations, warranties and covenants may change after the date of the Merger Agreement, which subsequent information may or may not be fully reflected in public disclosures by HCC or UAB. Accordingly, investors should read the representations and warranties in the Merger Agreement not in isolation but only in conjunction with the other information about HCC or UAB and their respective subsidiaries that HCC includes in its reports, statements and other filings made with the SEC.

Shareholder Agreements

HCC entered into shareholder agreements with ATB and each of the directors of UAB, as shareholders of UAB. The shareholder agreements generally require such shareholders to vote all of their UAB Common Shares (and in addition in the case of ATB, all of its UAB preferred stock) in favor of the approval of the principal terms of the Merger Agreement and certain related matters as applicable, and against alternative transactions and generally prohibit them from transferring their shares, subject to certain exceptions. The shareholder agreements will terminate in certain circumstances, including upon the consummation of the Merger or the termination of the Merger Agreement in accordance with its terms.

Non-Competition / Non-Solicitation Agreements

HCC entered into agreements with ATB and each director and certain executive officers of UAB in connection with the Merger Agreement, pursuant to which such directors, executive officers and ATB agreed to certain customary non-solicitation restrictions. In addition, the directors and ATB agreed to certain non-compete provisions that extend for a two year period from the effective date of the Merger.

The foregoing descriptions of the Merger Agreement, the shareholder agreements and the non-competition/non-solicitation agreements do not purport to be complete and are qualified in their entirety by reference to the Merger Agreement (and the annexes included therein) attached hereto as Exhibit 2.1, which is incorporated by reference herein.

Tri-Valley Bank Merger

On December 20, 2017 HCC announced that it had entered into an agreement and plan of merger and reorganization with Tri-Valley Bank pursuant to which Tri-Valley Bank will merge with Heritage Bank of Commerce. Tri-Valley shareholders will receive in the merger an exchange ratio of 0.0489 of a share of HCC common stock, or an aggregate of approximately 1.9 million shares. The exchange ratio is fixed and the aggregate and per share values of the merger consideration will fluctuate between the date of the agreement and the date that the merger is completed which is expected in the second quarter of 2018.

As of September 30, 2017, on a pro forma consolidated basis the combined company, including HCC, Tri-Valley Bank, and UAB, would have approximately \$3.3 billion in total assets, \$1.9 billion in total loans, and \$2.9 billion in total deposits. On a pro forma basis, the shareholders of UAB and of Tri-Valley will own approximately 11.0% (with ATB owning 5.4%) of the issued and outstanding HCC common stock on a combined basis following the completion of both mergers.

HCC is filing an investor presentation, which provides supplemental information regarding the proposed transaction in connection with a presentation to analysts and investors and discusses certain elements of the Merger, which it intends to post on the investor relations portion of its website, which is located at www.heritagecommercecorp.com. The investor presentation is included as Exhibit 99.2 to this report.

The joint press release and the investor presentation shall not be deemed to be filed for the purposes of Section 18 of the Securities Exchange Act of 1934, as amended (the Exchange Act), or otherwise subject to the liability of that section, and shall not be incorporated by reference into any registration statement or other document filed under the Securities Act of 1933, as amended, or the Exchange Act, except as shall be expressly set forth by specific reference in such filing.

In addition, HCC may file other documents regarding the proposed transaction with the SEC. **This communication does not constitute an offer to sell or a solicitation of an offer to buy any securities or a solicitation of any vote or approval.** Before making any voting or investment decision, investors and security holders of UAB are urged to carefully read the entire registration statement and proxy statement/prospectus, when they become available, as well as any amendments or supplements to these documents, because they will contain important information about the proposed transaction. A definitive proxy statement/prospectus will be sent to the shareholders of UAB seeking any required shareholder approvals.
