BHP Billiton Limited announces that on 11 October 2006 it purchased 250,000 ordinary shares of BHP Billiton Plc at an average price of 942.81 pence per ordinary share.

Following the above purchase, BHP Billiton Plc holds 25,420,000 of its ordinary shares as treasury shares and BHP Billiton Limited holds 15,890,000 of the ordinary shares in BHP Billiton Plc, for a total of 41,310,000 shares.
