Rights Agreement Amendment
On July 27, 2018, Sanchez Energy Corporation (the <i>Company</i> ) and Continental Stock Transfer & Trust Company, as rights agent (the <i>Rights Agent</i> ), entered into a second amendment (the <i>Amendment</i> ) to the Rights Agreement, dated as of July 28, 2015, between the Company and the Rights Agreement (the <i>Rights Agreement</i> ) to extend the Final Expiration Date of the Rights pursuant to the Rights Agreement from July 27, 2018 to July 26, 2021.
