**Vale announces dates for reporting of 1Q19 performance**

Rio de Janeiro, April 09, 2019 – Vale S.A. ( Vale ) will release its 1Q19 financial performance report on Thursday, May 09, 2019, after markets closure. Vale will simultaneously release the consolidated financial statements in USD and BRL, in accordance with the IFRS (International Financial Reporting Standards).

Vale will release its 1Q19 production and sales report on Wednesday, May 08, 2019, before the opening of the markets.

On Friday, May 10, 2019, Vale will host two conference calls and webcasts to discuss its 1Q19 performance. The first one, in Portuguese (non-translated), will begin at 10:00 a.m. Rio de Janeiro time. The second one, in English, will begin at 12:00 p.m. Rio de Janeiro time (09:00 a.m. New York time, 2:00 p.m. London time).
