On December 10, 2012, 1,333 shares that were acquired by the reporting person pursuant to the award of restricted stock units in December 2010 vested and were paid to the reporting person. 478 of these 1333 shares were withheld to pay the resulting tax liability. In (1) the Form 4 filed by the reporting person on December 12, 2012, the number of shares withheld to pay the resulting tax liability was erroneously reported as 486, rather than 478, due to an error in the information supplied to the reporting person by the issuer. The purpose of this Amendment is to correct that number.
