PricewaterhouseCoopers LLP (or a predecessor firm, Price Waterhouse) ( PwC ) have been the auditors of the Registrant since 1992.

On October 30, 2003, the Registrant's Audit, Finance & Risk Committee adopted a policy that requires pre-approval by the Audit, Finance & Risk Committee of any services to be provided by the auditors, whether audit or non-audit services. During the years ended December 31, 2003 and 2004, all audit and non-audit services were pre-approved by the Audit, Finance & Risk Committee.
