(1) The Form 4 originally filed on March 6, 2017 erroneously included a reduction in the Reporting Person's beneficial ownership by 163 shares representing shares withheld at vest to cover the Reporting Person's tax obligation. There was no reduction in shares as the vest event was reported in error and so this amendment returns the 163 shares to the Reporting Person's beneficial ownership reported in Column 5.
