The transaction code for the first entry is S/K4 and the transaction code for the second entry is P/K4. On November 10, 2007, the reporting person entered into a zero-cost collar arrangement pursuant to which he wrote a covered call option and purchased a put option. If neither option is exercised by the expiration date, both options expire.
