The shares sold on March 30, 2011 that are being reported on this Form 4 were owned indirectly by Elliott Associates, L.P. ("Elliott Associates") through The Liverpool Limited Partnership, its wholly-owned subsidiary ("Liverpool"). Elliott Associates directly owns 1,741,940 shares of common stock and indirectly owns 1,684,061 shares through Liverpool.

(2) Elliott Associates also indirectly owns \$24,516,000 in principal amount of the issuer's 2-3/8% Convertible Bonds due May 15, 2017 through Liverpool.
