(2) Represents the sale of shares in [606 ] separate transactions, ranging in price from \$16.84 to \$17.34, resulting in a weighted average sale price per share of \$17.11. The reporting person will provide, upon request by the SEC staff, the Issuer or a security holder of the Issuer, full information regarding the number of shares sold at each separate price within the range.

(3) Represents the sale of shares in [340 ] separate transactions, ranging in price from \$16.90 to \$17.18, resulting in a weighted average sale price per share of \$17.07.
