In relation to and as part of the transactions contemplated under the H Share Specific Mandate, a subscription agreement entered into between CES Global and the Company on 10 July 2009, under which, CES Global agrees to subscribe for, and the Company agrees to issue, not more than 490,000,000 new H Shares at the subscription price of not less than HK\$1.40 per H Share

The respective EGM and class meetings of the Company were held on 7 September 2009 where the shareholders have approved the H Share Specific Mandate.
