Represents the sale of 5,575 shares in 7 separate transactions, ranging from \$58.40 to \$58.75 per share, resulting in a weighted average sale price per share of \$58.5405. The Reporting Person undertakes to provide upon request by the SEC staff, the Issuer, or a security holder of the Issuer, full information regarding the number of shares sold at each separate price within the range.

(2) Represents options to purchase the Issuer's Class A Common Stock, \$0.001 par value ("Common Stock").

An option to purchase 10,000 shares of the Issuer's Common Stock was issued to the Reporting Person under the Issuer's 2005 Omnibus Equity Plan. 2,500 shares of Common Stock became exercisable on each of October 16, 2009 and October 16, 2010, and an additional 2,500 shares of Common Stock become exercisable on each of October 16, 2011 and October 16, 2012.

An option to purchase 12,303 shares of the Issuer's Common Stock was issued to the Reporting Person under the Issuer's 2005 Omnibus Equity Plan. 3,075 shares of Common Stock became exercisable on October 13, 2010 and 3,076 shares of Common Stock become exercisable on each of October 13, 2011, October 13, 2012 and October 13, 2013.
