On October 22, 2013, First Community Bancshares, Inc.'s (the "Company") board of directors declared its quarterly cash dividend to common shareholders of twelve cents (\$0.12) per common share, payable on or about November 22, 2013, to shareholders of record on November 8, 2013. Additionally, the Company's board of directors also authorized the repurchase and retention of up to 3,000,000 of its outstanding common shares. The updated repurchase plan will allow the Company to buy an additional 2.4 million shares of its common stock. A copy of the press release is attached hereto as Exhibit 99.1.
