This Schedule 13G/A is being jointly filed by Citadel Advisors LLC ("Citadel Advisors"), Citadel Advisors Holdings II LP ("CAH2"), Citadel GP LLC ("CGP") and Mr. Kenneth Griffin (collectively with Citadel Advisors, CAH2 and CGP, the "Reporting Persons") with respect to American Depositary Shares (and options to purchase ordinary shares) of the above-named issuer owned by Citadel Equity Fund Ltd., a Cayman Islands limited company ("CEF"), Citadel Global Equities Master Fund Ltd., a Cayman Islands limited company ("CG"), Citadel Quantitative Strategies Master Fund Ltd., a Cayman Islands limited company ("CQ"), and Citadel Securities LLC, a Delaware limited liability company ("Citadel Securities").
