 - (3) Includes reinvestment of dividends paid on shares held in Rabbi trust for non-management directors.
 - (4) Shares are held in a Rabbi trust for non-management directors. Director exercises voting rights but no right to dispose until directorship ends.
 - (5) Shares held in Trane Inc.'s ESOP and Savings Plan.
