- (1) On April 8, 2013, certain parties to the Sale and Purchase Agreement entered into on April 25, 2012 between the issuer, Actavis Acquisition Debt S.a.r.l., Nitrogen DS Limited ("Nitrogen") and the other parties thereto (the "Agreement") became entitled to receive shares of issuer common stock pursuant to the terms of the Agreement. As part of the foregoing arrangement and based on an agreement entered into in 2007 between the reporting person and Nitrogen while the reporting person was an executive of the Actavis Group (prior to its acquisition by the issuer), the reporting person became entitled to receive 8,163 shares of issuer common stock on April 8, 2013.
 - (2) The number of shares issuable pursuant to the Agreement is based upon year over year (2011 to 2012) growth in cash EBITDA for the Actavis business the issuer acquired in October 2012 and is not tied to the stock price of the issuer or any other company.
