- (1) On January 14, 2014, the reporting person gifted 750 shares of common stock to an educational institution.

- (3) The phantom stock units were issued pursuant to a Multi-Year Deferred Compensation Agreement pursuant to the Company's dividend paid on January 15, 2014 solely in respect of vested phantom stock units.
- (4) The phantom stock units are not subject to expiration and shall become payable within 30 days after the earliest to occur of any Triggering Event.
