Mr. Javitt acquired the warrant to purchase shares of common stock of Brainstorm Cell Therapeutics Inc. ("Brainstorm") from Ramot at Tel Aviv University Ltd. ("Ramot") pursuant to a Warrant Purchase Agreement (the "Agreement") between ACCBT Corp. ("ACCBT") and Ramot dated August 2, 2007. Pursuant to the Agreement, ACCBT had the right to acquire a warrant from Ramot to purchase an aggregate of 3,181,925 shares of common stock of Brainstorm. On September 6, 2007, ACCBT designated Mr. Javitt under the Agreement as the purchaser of a warrant from Ramot to purchase an aggregate of 1,000,000 shares of common stock of Brainstorm.
