The reporting person disclaims beneficial ownership of these securities except to the extent of his pecuniary interest therein.

The reporting person disclaims beneficial ownership of these securities except to the extent of his pecuniary interest therein.
- (3) This transaction was executed in multiple trades at prices ranging from \$61.95 to \$62.91. The price reported above reflects the weighted average purchase price. The reporting person hereby undertakes to provide upon request to the SEC staff, the Issuer or a security holder of the Issuer full information regarding the number of shares and prices at which the transactions were effected.
