Unilever NV announces that on 5 October 2007 it purchased 250,000 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 21.270 and euro 21.880 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 5,103 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 98,272,941 Unilever NV ordinary shares in treasury, and has 1,616,454,759 Unilever NV ordinary shares in issue (excluding treasury shares).
