Our previous sales guidance for the second quarter of fiscal year 2005, encompassing the reporting period of May 1, 2005 to July 30, 2005, was for total sales to be in the range of \$755 to \$770 million. As of July 7, the Company s sales may be characterized as in line with guidance, and we are reaffirming that range.

As of July 7, 2005, we operated 2,845 stores in 48 states, compared to 2,602 stores in 47 states at July 3, 2004.
