At this time, the special committee has neither completed its review, nor reached any preliminary or final conclusions about the Company s stock option practices and the related accounting treatment. Until the special committee s review is complete, the Company will be unable to prepare and file its Form 10-Q. The Company intends to file its Form 10-Q as soon as practicable after the completion of the special committee s review.
