(a) Amount beneficially owned:

QVT Financial LP (QVT Financial) is the investment manager for QVT Overseas Ltd., which beneficially owns 4,023,695 shares of Common Stock. QVT Financial is also the investment manager for QVT Fund LP, Quintessence Fund L.P., QVT Associates LP, QVT Global II L.P., Quintessence Global II L.P., Quintessence Associates LP and Quintessence Overseas L.P. (each, a Fund and collectively, the Funds). The Funds beneficially own an aggregate amount of 4,198,070 shares of Common Stock. In addition, QVT Financial is the investment manager for a separate discretionary account managed for Deutsche Bank AG (the Separate Account), which holds 1,644,273 shares of Common Stock. QVT Financial has the power to direct the vote and disposition of the Common Stock held by QVT Overseas Ltd., each of the Funds and the Separate Account. Accordingly, QVT Financial may be deemed to be the beneficial owner of an aggregate amount of 9,866,038 shares of Common Stock, consisting of the shares owned by QVT Overseas Ltd. and the Funds and the shares held in the Separate Account.

QVT Financial GP LLC, as General Partner of QVT Financial, may be deemed to beneficially own the same number of shares of Common Stock reported by QVT Financial. QVT Associates GP LLC, as General Partner of the Funds, may be deemed to beneficially own the aggregate number of shares of Common Stock owned by the Funds. Accordingly, QVT Associates GP LLC may be deemed to be the beneficial owner of an aggregate amount of 4,198,070 shares of Common Stock.

Each of QVT Financial and QVT Financial GP LLC disclaims beneficial ownership of the shares of Common Stock owned by QVT Overseas Ltd. and the Funds and the shares held in the Separate Account. QVT Associates GP LLC disclaims beneficial ownership of all shares of Common Stock owned by the Funds, except to the extent of its pecuniary interest therein.

The percentage disclosed in Item 11 of the Cover Pages for each reporting person is calculated based on 58,375,726 shares of Common Stock outstanding, which is the total number of shares issued and outstanding reported in the Issuer s Free Writing Prospectus filed with the Securities and Exchange Commission pursuant to Rule 433 on December 5, 2007.
