Proposals to be considered at the Annual Meeting:

- (1) to elect three Class II Directors to serve until the 2014 Annual Meeting of Stockholders of the Company;
- (2) to ratify the appointment of KPMG, LLP as the Company's independent registered public accounting firm for 2011;
- (3) to approve, by a non-binding advisory vote, the compensation of the Company's named executive officers;
- (4) to approve, by a non-binding advisory vote, the frequency of future stockholder votes on executive compensation;
- (5) to approve the amendment and restatement of the Company's Stock Award Plan; and
- (6) to consider and act upon any other business that may properly come before the meeting or any adjournment(s) thereof.
