**Item 5.05 Amendments to the Registrant's Code of Ethics, or Waiver of a Provision of the Code of Ethics.**

On February 7, 2012, the Company amended its Code of Business Conduct and Ethics (the *Code*). The amendments are primarily intended to address in greater detail various aspects of the Company's business related to the marketing and sale of pharmaceutical products. In particular, the amended Code addresses compliance with applicable laws, regulations and guidelines with respect to (i) interactions with and payments to healthcare professionals, (ii) claims submitted to government healthcare programs, (iii) the handling of patient information, (iv) adverse event reporting, (v) conducting business abroad and (vi) the testing, manufacture, promotion and labeling of pharmaceutical products. The amendments to the Code also incorporate certain aspects of the Company's employee handbook and the Company's recently-established compliance program and other internal resources designed to enhance compliance with the Code and applicable laws.
