This Report of Foreign Private Issuer on Form 6-K is deemed filed for all purposes under the Securities Act of 1933, as amended, and the Securities Exchange Act of 1934, as amended.

Korea Electric Power Corporation ( KEPCO ) has been recently informed that on April 26, 2012, the Nigerian Court of Appeal made a ruling on the appeal by Owel Petroleum Services Nigeria Ltd. ( Owel ) in relation to the Federal High Court s decision in 2009 to invalidate the unilateral cancellation by the Nigerian government of the exploration rights held by a consortium consisting of us and two other Korean companies, namely, Korea National Oil Corporation, a government-controlled enterprise, and Daewoo Shipbuilding & Marine Engineering, for certain deep sea oil exploration projects in Nigeria. Among other things, the ruling stated that the Nigerian government has taken illegal steps in notifying us of its decision to cancel the consortium s exploration rights, but specified that the Federal High Court did not have proper jurisdiction to rule on this matter and further that additional agreements relating to discounts on the contract price were invalid. We are currently assessing the implications of this ruling on our Nigerian government also appealed the 2009 decision by the Federal High Court, but such appeal remains pending at the Nigerian Court of Appeal. For further details on this litigation as well as our projects in Nigeria, see our report on Form 6-K dated September 2, 2009 and page 63 of our annual report on Form 20-F filed with the Commission on April 30, 2012.
