Item 2.01 Completion of Acquisition or Disposition of Assets.

On July 3, 2012, a wholly-owned subsidiary of Terreno Realty Corporation (collectively referred to as the Company), completed the acquisition of an industrial property located in the San Francisco Bay Area consisting of two R&D buildings and one industrial building, aggregating approximately 172,000 square feet (the Property), from a third-party seller (the Seller), for a net purchase price of approximately \$33.7 million. The Company utilized borrowings from its senior revolving line of credit to fund the acquisition.

There are no material relationships between the Seller and the Company or any of its affiliates, or any director or officer of the Company, or any associate of any such director or officer, other than in respect of the acquisition of the Property.
