The filing of this Schedule 13G/A shall not be construed as an admission that Manouch Moshayedi is, for purposes of Section 13(d) or 13(g) of the Act, the beneficial owner of shares held by the Revocable Trust.
- (2) Does not include 1,133,923 shares that were gifted to a separate trust on May 9, 2012 for the benefit of Manouch Moshayedi s descendants. Mr. Moshayedi disclaims beneficial ownership of the shares held by that trust.
