Dear Travel Professional:

One thing we committed to do when we announced our planned merger with US Airways was to keep our customers and partners in the travel industry informed of our progress. In keeping with this commitment, I am pleased to provide the following update.

Merger planning has recently commenced with 29 integration teams, including one focused on our sales and account management functions, to define the manner in which American and US Airways will combine our commercial, customer service, operations and corporate functions after the merger closes.

This week a number of the teams met in Dallas/Fort Worth with a focus on the most pressing work that must be accomplished during the months leading up to the close of the merger, including what our customers see and hear from us on the first day as a combined airline group and how we bring our more than 100,000 employees together as one team.

As this work progresses, we continue to welcome your feedback. A lot of you have shared with us your experiences of airlines that already have merged, and we are using this learning as we plot our unique course.

We still expect the merger to close in the third quarter of this year, and we will then move forward with a plan that leads to the day we operate as a single carrier. That could be 18 months or more from the time the merger closes, but the date is less important than the details, which we are working very hard to get right.

The most important thing we can do, and will do, is to ensure a strong future for the new American by continuing to operate our respective airlines safely, and on time, and focused on our customers and partners in the travel industry.

Thank you for your continued support and we look forward to welcoming you onboard soon.
