The Special Committee of the Board of Directors announced that it received a revised proposal from Michael and global technology investment firm Silver Lake under which they would increase the price at which they would acquire the company to \$13.75 per share in cash, subject to certain conditions.

Specifically, the revised proposal would require that the merger agreement be amended to require approval of the transaction by a majority of the unaffiliated shares (i.e., all outstanding shares other than shares held by Michael and his related family trusts, the Board and certain members of management) actually voted in favor of or against the transaction. Currently, the merger agreement requires approval by a majority of all outstanding unaffiliated shares, including shares that vote to abstain or aren't voted at all.

In light of the revised proposal, which the Special Committee is evaluating with the assistance of its financial and legal advisors, the Special Meeting of Stockholders previously scheduled to be reconvened today will be adjourned to August 2 at 9:00 a.m. Central Daylight Time at the Dell Round Rock Campus.

As always, we will continue to keep you informed as the pending transaction moves toward completion.

While the Special Committee continues to manage the transaction process, we appreciate your patience, your ongoing engagement with customers and focus on delivering results.
