Mercer International Inc. (the Registrant) is filing this registration statement on Form S-8 (the Registration Statement) to register an additional 2,000,000 shares of the Registrant's common stock, par value \$1.00 per share, for issuance under the Mercer International Inc. 2010 Stock Incentive Plan, as amended effective May 30, 2014. In accordance with General Instruction E to Form S-8, this Registration Statement hereby incorporates by reference the contents of the registration statement on Form S-8 previously filed by the Registrant with the Securities and Exchange Commission (the SEC) on June 11, 2010 (File No. 333-167478), except to the extent otherwise updated or modified by this Registration Statement.
