### **Item 8.01 Other Events**

On November 10, 2014, PowerSecure International, Inc., a Delaware corporation (the Company), issued a press release announcing it has strengthened and realigned its leadership team. As part of this leadership initiative, Christopher T. Hutter, the Company's Executive Vice President and Chief Financial Officer, will remain with the Company and transition to the newly created role of Chief Operating Officer of the Company.
