On and after March 19, 2020, the Series D Preferred Stock represented by the Depositary Shares may be redeemed at AmTrust Financial Services, Inc.'s option, for cash, in whole or in part, at a redemption price equal to \$1,000 per share (equivalent to \$25 per Depositary Share), plus declared and unpaid dividends on the shares of Series D Preferred Stock called for redemption, if any, for prior dividend periods, if any, plus accrued but unpaid dividends (whether or not declared) thereon for the then-current dividend period to, but excluding, the date of redemption, without accumulation of any other undeclared dividends. The Depositary Shares will be redeemed if and to the extent that the related shares of Series D Preferred Stock are redeemed by AmTrust Financial Services, Inc. Holders of Depositary Shares will not have the right to require the redemption or repurchase of the Series D Preferred Stock.
