The combination of STERIS Corporation and Synergy Health plc was undertaken in November 2015 for strategic reasons. The combined business, STERIS plc ( "STERIS" ), is domiciled in the UK where Synergy Health plc was headquartered and which was STERIS Corporation's second largest country of operation. STERIS continues to believe that its effective tax rate will be approximately 25%. STERIS will continue to evaluate tax laws and regulations and will provide appropriate disclosure concerning any potential material impact on STERIS, if applicable.
