On May 12, 2016, Intelsat S.A. issued a press release announcing that Intelsat S.A.'s indirect wholly-owned subsidiary, Intelsat Jackson Holdings S.A., commenced tender offers to purchase its 6 <sup>5</sup>/<sub>8</sub>% Senior Notes due 2022, 5 <sup>1</sup>/<sub>2</sub>% Senior Notes due 2023 and 7 <sup>1</sup>/<sub>2</sub>% Senior Notes due 2021 for up to \$625,000,000 in aggregate cash consideration (excluding accrued and unpaid interest on the notes and excluding certain fees and expenses related to the tender offers), subject to certain terms and conditions.
