**Item 2.02. Results of Operations and Financial Condition**

On October 27, 2016, LogMeIn, Inc. (the Company ) announced its financial results for the third quarter of 2016. The full text of the press release issued in connection with the announcement is furnished as Exhibit 99.1 to this Current Report on Form 8-K.

As contemplated by the definitive merger agreement with Citrix, the Company currently expects to declare a third dividend of \$0.50 per share of common stock subject to the consummation of the transaction, on or about the date of such consummation.
