The restricted stock units will be earned on December 31, 2005 provided certain pre-tax profit targets are achieved by GPC for fiscal year 2005. If earned, the units will vest and convert to shares of common stock on December 31, 2009 provided the reporting person is still employed on that date, subject to earlier vesting in certain events.
