Prior to the reported transactions, the reporting person beneficially owns 97.0% of the equity interest in CPEX directly and holds an irrevocable proxy to vote the remaining 3.0%. Additionally, as previously reported, the reporting person also indirectly beneficially owns shares that are owned directly by the reporting person's spouse.
