Units are owned by Calumet, Incorporated ("Inc."). On April 16, 2007, Mr. Grube sold his entire interest in Inc. The units held by Inc. were valued at a price of \$52 per unit in the sale. Prior to the sale, Mr. Grube was a shareholder and director of Inc. Mr. Grube disclaims

(1) beneficial ownership of the units of the Issuer owned by Inc. except to the extent of his pecuniary interest therein, and the inclusion of the units in this report shall not be deemed an admission of beneficial ownership of all the reported units for purposes of Section 16 or for any another purpose.

Units owned by Mr. Grube's spouse. Mr. Grube disclaims beneficial ownership of these units, and the inclusion of these units in this

(2) report shall not be deemed an admission of beneficial ownership of the reported units for purposes of Section 16 or for any another purpose.

Units are owned by two trusts for the benefit of Mr. Grube's spouse and children. Mr. Grub's spouse is the trustee of the trusts. Mr. Grube

(3) disclaims beneficial ownership of these units, and the inclusion of these units in this report shall not be deemed an admission of beneficial ownership of the reported units for purposes of Section 16 or for any another purpose.

Each Subordinated Unit will convert into one Common Unit at the end of the subordination period, which will end once the Issuer meets certain financial tests set forth in the agreement of limited partnership of the Issuer, but not before December 31, 2010. These financial

(4) tests include the requirement that the Issuer have earned and paid the minimum quarterly distribution and arrearages (if any) on all of its outstanding units for three consecutive, non-overlapping four-quarter periods.
