- Represents shares of performance based restricted stock units granted to the filing person on December 10, 2009. The vesting of the shares of performance based restricted stock units was conditioned upon the achievement of certain 2010 earnings before interest, taxes, depreciation, and amortization ("EBITDA") performance versus pre-established targets. The restricted stock units vest over three years
- (1) (1/3 on February 11, 2011; 1/3 on January 1, 2012; and 1/3 on January 1, 2013). Of the 34,988 shares of common stock, 11,661 shares were issued on February 11, 2011, of which 5,068 shares were withheld to satisfy payment of the Issuer's tax withholding obligation. The remaining 23,327 shares are scheduled to be issued on the two remaining vesting dates and taxes for these future issuances will be withheld at the time the shares are issued.
